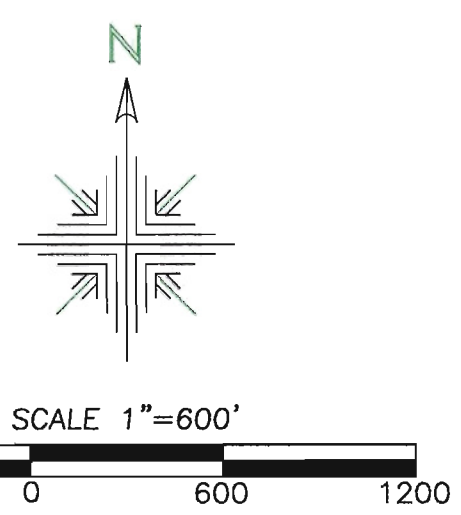


SUBDIVISION PLAT OF Wagon Track Ranch

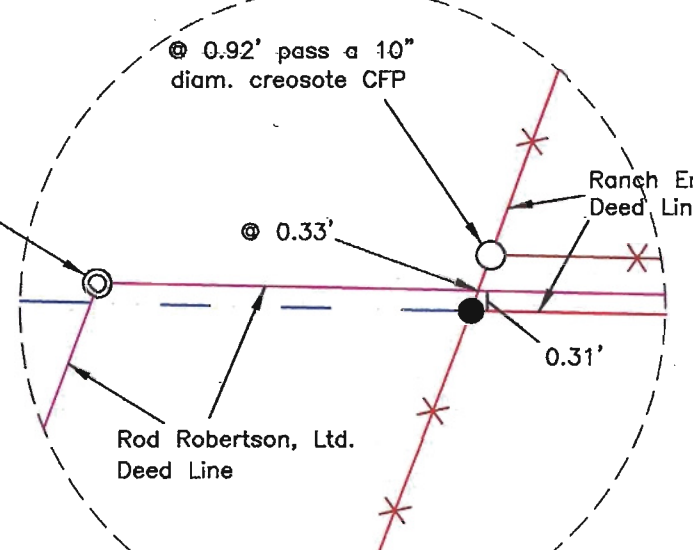
DETAIL "C"

NOT TO SCALE



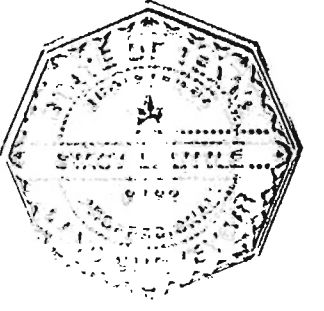
